### 1. GENERAL

The Cup of Berlin 2010 is an ISU Synchronized Skating Competition for Juniors and Seniors and an Interclub Competition for Novice-Teams hosted by the Deutsche Eislauf-Union e.V. and organized with the support of the Berliner Eissport Verband e.V in Berlin, Germany, from 15<sup>th</sup> to 16<sup>th</sup> January 2010.

The Cup of Berlin 2010 will be conducted in accordance with the *ISU Constitution and General Regulations 2008*, the *ISU Special Regulations an Technical Rules Synchronized Skating 2008* and all relevant *ISU communications*.

Participation in the Cup of Berlin 2010 is open to all teams who belong to an ISU Member and whose team members qualify with regard to eligibility according to Rule 102, provided their ages fall within the limits specified in Rule 108, paragraph 3) and meet the participation, citizenship and residency requirements in Rule 109. Passports of the skaters, as well as the ISU Clearance Certificate, if applicable, must to be presented at the accreditation

A Novice Team shall consist of 16 skaters; all of whom must have reached the age of ten (10) and may not have reached the age of fifteen (15), before July 1<sup>st</sup> 2009.

A Junior Team shall consist 16 skaters; all of whom must have reached the age of twelve (12) and may not have reached the age of nineteen (19), before July 1<sup>st</sup> 2009.

A Senior Team shall consist of 16 skaters; all of whom must have reached the age of fourteen (14) before July 1<sup>st</sup> 2009.

### 3. TECHNICAL DATA

ISU Rules shall be in effect according to *ISU Special Regulations Synchronized Skating 2008* as well as all pertinent ISU Communications. The following has to be noted: each participating team may enter up to four (4) alternates on the official Entry Form; Teams may include both boys/Men and girls/Women without restrictions; Teams of a Member Federation may enter more than one category using different music and different Programs, with a minimum change of 50% of the skaters. Only those skaters whose names are listed on the registration forms will be allowed to skate.

##### Novice Teams

Free Skating: 3 min. 30 sec. +/- 10 sec.

The free skating must be a balanced program according to ISU Communication No.1528, ISU Regulations for Synchronized Skating 2008 and all pertinent ISU Communication.

##### Junior Teams

Short Program: max. 2 min. 50 sec., but may be less  
Program Standards according to Rule 905, paragraph 1. a).

The required elements to be skated are listed in ISU Special Regulations Synchronized Skating 2008, Rule 905, paragraphs 1 and 2, Group B and all pertinent ISU Communication.

Free Skating: 4 min. +/- 10 sec.

The free skating must be a balanced program according to ISU special Regulations for Synchronized Skating 2008, Rule 911 and all pertinent ISU Communication.

Multiplying Factors:

In accordance with ISU Special Regulations for Synchronized Skating 2008, Rule 738, paragraph 1 p) the factors for the Program Components are

##### Senior Teams

Short Program: max. 2 min. 50 sec., but may be less  
Program Standards according to Rule 905, paragraph 1. a).

The required elements to be skated are listed in ISU Special Regulations Synchronized Skating 2008, Rule 905, paragraphs 1 and 2, Group B and all pertinent ISU Communication.

Free Skating: 4 min. 30 sec. +/- 10 sec.

The free skating must be a balanced program according to ISU special Regulations for Synchronized Skating 2008, Rule 911 and all pertinent ISU Communication.

Multiplying Factors:

In accordance with ISU Special Regulations for Synchronized Skating 2008, Rule 738, paragraph 1 p) the factors for the Program Components are

Short Program	0,8
Free Skating	1,6

#### 4. PLANNED PROGRAM CONTENT

The "Program Content Sheet" must be returned to the Organizing Committee together with the entry forms within the deadline. It is mandatory that the Program Content Sheet is filled in precisely by each team in English using the terminology for the elements listed in the Scale of Value Table published in *ISU Special Regulations Synchronized Skating 2008* as well as in all pertinent ISU Communications.

#### 5. RESULT CALCULATIONS

All results will be calculated using an electronic computer according to the *ISU Special Regulations Synchronized Skating 2008*, Rule 738ff ("ISU Judging System").

The three best-placed Teams in each event will be announced and honoured at the official Award Ceremony. The national anthem of the winner will be played and the flags of the medal winners hoisted on a screen. The best team will win the cup.

#### 6. MUSIC

Rule 905 and Rule 911 shall apply. Vocal music using lyrics is permitted. Additions of sounds of applause or cheers are not permitted.

All Teams shall furnish competition music of excellent quality on either cassettes or CD format. Each program (short/free) must be recorded on one track and on a separate disc or cassette. Cassettes and CDs must show the event (Novice, Junior or Senior), the Team's name and nation and the exact running time of the music (not skating time) including any starting signal, and must be turned in at the time of registration.

The titles, composers and orchestras of the music to be used for the Short Program and Free Skating must be listed for each Team on the official Music Information Form and attached to the official Entry Form for Teams.

If the Music Information is not completed and cassettes, tapes or discs are not provided, accreditation will not be given.

#### 7. PRACTICE

The Official Practice in the Sportforum Hohenschönhausen (Competition Rink) will start on Friday morning, January 15<sup>th</sup> starting with the Novice Teams followed by Junior and Senior Teams according to starting order. Each Team will be allowed a ten (10) minutes' period of Official Practice Ice for the Short Program, free of charge. On Saturday morning will be an Official Practice, a twelve (12) minutes' period for the Junior's and Senior's Free Skating Program, free of charge.

**Additional practice ice can be booked** in the Erika Heß Stadion (Additional Practice Rink). The Erika Heß Eisstadion. Additional practice is available on Wednesday, January 13<sup>th</sup>, and Thursday, January 14<sup>th</sup>, 08:00 h until 22:00 h each day.

#### 8. TECHNICAL AND JUDGES PANEL

Each participating ISU Member may nominate one (1) Judge, listed on the ISU list of Referees and Judges for Synchronized Skating 2009/2010. The host ISU Member may nominate two (2) Judges listed on the ISU list of Referees and Judges for Synchronized Skating 2009/2010.

The Referees, Technical Specialists and Technical Controller will be nominated by the Organizing Committee and chosen from the respective ISU list for Synchronized Skating 2009/2010. The official Judges' Nomination Form must be sent to addresses mentioned under 2.) not later than **November, 13<sup>th</sup> 2009**.

**The Referees and TC meeting** will be held on Thursday, January 14<sup>th</sup> 2010 at 17:00 h at the Holiday Inn Hotel. **The Draw for the Panel of Judges** will be made at the **Judges' Meeting** which will be held on Thursday, January 14<sup>th</sup> 2010 at 17:30 h.

#### 10. REGISTRATION / ACCREDITATION

Accreditation will be given to ISU Office Holders and Guests, the Technical Panel and the Judges, Participants (Team Members), one Team Manager and one Coach per Synchro-Team. Not more than 2 Officials, one Team Leader and one Medical Attendant of each ISU Member will also receive an accreditation provided they are Council Members of their National Federation (including Presidents) or the General Secretary of the Head Office of their Federation. Each Member Federation confirms the function of each Team Member with the official entry form "Composition of Delegation".

The registration for the Technical Panel, Referees, Judges, Teams, Accredited Coaches, Team Leaders and Team Managers will be given at Holiday Inn Berlin City East, from Wednesday morning on.

#### 11. INSURANCE / LIABILITY

In accordance with Rule 119, it is the sole responsibility of each Member participating in ISU Events, to provide medical and accident insurance for their athletes, officials and all other members of the Member's team. Such insurance must assure full medical attendance and also the return of the ill or injured person to the home country by air transport or by other expeditious means. It is an internal matter of each ISU Member to decide the issue who shall pay the premium for such insurance.

The ISU and the Deutsche Eisläufer-Union assume no responsibility for or liability with respect to bodily or personal injury or property damage incurred by Competitors and Officials.
